Parkour Visions is a non-profit organization dedicated to promoting the positive benefits of parkour through teaching, design and advocacy.

Teach program: In 2017, we took on 12 apprentices, of which 9 were certified and 7 went on to coach and provide programs with us. The Parkour Visions certification is one of the longest running, in-depth coaching course available in the country, and all qualified applicants received a complete scholarship for this \$3,000 program. We continued our partnership with Fred Hutch Cancer Center research as well as the Overlake School, and established a partnership with the Associated Recreation Council. By the end of the year, we were able to offer over 3,000 free or reduced cost entries to our classes in our main facility, and reached over 4,000 unique students. Unfortunately in November Parkour Visions closed its main facility and temporarily ceased all programming through the end of the year.

Build Program: 2017 was a banner year for Parkour Vision's design arm. Our first major park project, Rhodes Park in Boise, ID, opened to the public. We also designed and opened an even larger public parkour park in Langley, BC. These projects represented a major step forward both for Parkour Visions as a design firm and for the legitimacy and popularity of outdoor parkour design in North America. In addition to these two major projects, we also produced equipment concepts for a trampoline park company, designed parkour additions to an urban treehouse for a private client, and designed and fabricated a playable sculpture for the Seattle AIA. We also volunteered our time on the 17th & Dock parklet project and several other concept designs for sites in the Puget Sound area

Share Program: In 2017, Parkour Visions ran our annual event, the Parkour Visions Classic, which included three days of games, jamming, and parkour around Seattle. We drew over 80 participants, including practitioners from Canada and neighboring states, and showcase 6 different parks. Our Head Coach was sent to teach at several major national events this year as well, in DC and Washington, sharing parkour with 150+ practitioners.
